## **2012** Blue Star Medical Group/IPA Report and Blue Ribbon Report<sup>™</sup>

The **Blue Star Medical Group/IPA Report and Blue Ribbon Report** recognizes HMO contracting medical groups/Independent Practice Associations (IPAs) that have documented high levels of performance in providing patient care. Annually, Blue Cross and Blue Shield of Illinois (BCBSIL) assesses medical group performance based upon national clinical practice and preventive care guidelines.

HMO members can use the Blue Star Medical Group/IPA Report and Blue Ribbon Report – along with the **Blue Star Hospital Report**<sup>SM</sup> – to help them choose health care providers that best meet their needs. To make it even easier for members to use the Report, this information is also linked to the **Provider Finder**<sup>®</sup>.

## Performance Measures and Results\*

Groups earn a "blue star" each time they meet or exceed the target care goal in one of the reporting categories. The number and percentage of groups earning a blue star are listed below.

## The criteria are:

- Asthma: A high level of performance in providing care for members with asthma was demonstrated based on the percentage of members who received a written asthma action plan, had an assessment of asthma control and had well controlled asthma. 69 medical groups earned a blue star
- **Diabetes:** A high level of performance in providing routine diabetes care was demonstrated by meeting at least five of seven care thresholds. **38 medical groups earned a blue star**
- **Breast Cancer Screening:** At least 72 percent of women age 42 to 69 had a mammogram between 1/1/2010 and 12/31/2011. **39 medical groups earned a blue star**
- Childhood Immunization: At least 78 percent of children who turned two years of age received recommended immunizations by their second birthday. 35 medical groups earned a blue star
- Mental Health Follow-up: At least 73 percent of members had a follow-up visit with a behavioral health practitioner within seven days of hospital discharge for a mental health diagnosis. 66 medical groups earned a blue star
- **Controlling High Blood Pressure:** At least 65 percent of members with hypertension had their blood pressure controlled (<140/90 mmHg). **52 medical groups earned a blue star**

- Colorectal Cancer Screening: At least 55 percent of members age 51 to 75 were current with screening for colorectal cancer in 2010. 57 medical groups earned a blue star
- Management of Cardiovascular Conditions: A high level of performance in providing care for members identified with cardiovascular disease was demonstrated based on the percentage of members who had cardiovascular risk factors assessed and controlled. 32 medical groups earned a blue star
- Cervical Cancer Screening: At least 76 percent of women age 24 to 64 had a Pap test between 1/1/2009 and 12/31/2011.
  37 medical groups earned a blue star
- **Physician and Member Outreach:** IPAs that completed all requirements. **89 medical groups earned a blue star**
- Adult Wellness: At least 40 percent of members age 18 and older had a BMI documented in 2010 or 2011. 80 medical groups earned a blue star
- **Pediatric Wellness:** At least 40 percent of members age 2 to 17 had a BMI percentile documented in 2011. **60 medical groups earned a blue star**
- Blue Ribbon Report: IPAs that scored at least 75 percent using the top 2 box scores on selected questions from the 2011 HMO Member Survey. 32 medical group sites earned a blue ribbon
