

Patient ID Finder is an online application that allows providers to obtain a Blue Cross and Blue Shield of Illinois (BCBSIL) patient insurance ID number and group number by entering patient-specific data elements, making it easier to obtain the needed patient information for your records.

This application is available for commercial, Federal Employee Program® (FEP®), on and off exchange plans, Medicare Advantage, and Illinois Medicaid members.

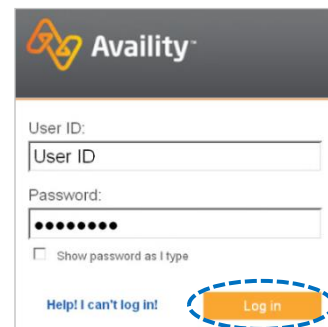

## 1) Getting Started

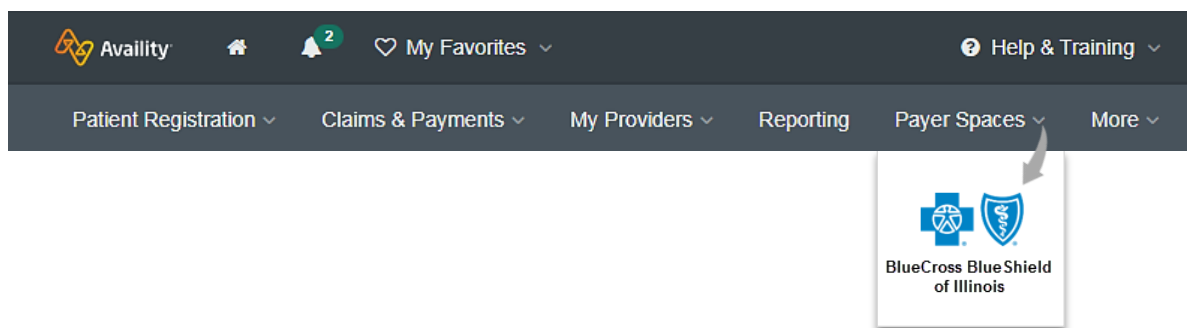
- ▶ Go to [Availity](#)

## 2) Accessing Patient ID Finder

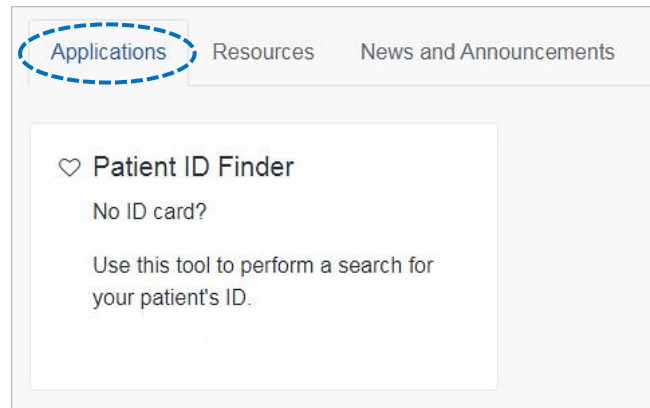
- ▶ Select [Payer Spaces](#) from the navigation menu

## 2) Accessing Patient ID Finder (continued)

- ▶ In the BCBSIL Payer Spaces section, select the **Applications** tab
- ▶ Next, select **Patient ID Finder**

**Note:** Contact your Availity administrator if the **Patient ID Finder** is not listed in **Applications**.



## 3) Searching for a Patient ID

Complete the following fields:

- ▶ Select **State**
  - ▶ *select the state where the patient's insurance policy resides*
- ▶ Select **Payer**
  - ▶ *choose **BCBSIL** for commercial patients*
  - ▶ *choose **BCBSIL – Medicare Advantage/Medicaid** for government program patients*
- ▶ Enter patient **First Name**
- ▶ Enter patient **Last Name**
- ▶ Select **Policy Type**
- ▶ Enter **Date of Birth**
- ▶ Enter **Last Four of SSN** – *not required for Medicare Advantage/Medicaid patients*
- ▶ Enter **ZIP Code**
- ▶ Select **Lookup Member**
