NOTICE:

If you are Medicare-eligible, age 65 or older, and enrolled in a Traditional plan (PPO, HSA or HMO), you will need to elect coverage in one of the HCSC group retiree Medicare plan options during this upcoming Open Enrollment. This means you will only be responsible for the group retiree Medicare plan costs. You will no longer pay the full cost difference between our HCSC group retiree Medicare plan and the Traditional plan, plus your portion of the coverage in which you enrolled.
